1. Welcome

Secretary

8. Ordinary Business

Proposed Development of Old School Site

Chairman reported that basement of property had been flooded by a burst pipe, however a repair has been carried out and the basement has been pumped out. He then asked Councillors if there was any update with regard to the site. Councillor Dettbarn reported that there are no further developments in respect of old school site development. A discussion followed.

Church Wall Repair

Fiona Ross, South Ayrshire Council, addressed meeting and reported that the tender has been awarded and a contractor appointed. The contractor is aiming to be on site for the end of November. The site presents a very difficult and sensitive piece of construction work and contractor intends to do some initial work at the steps the carry out a phased movement from there up towards the Manse house. There will be a partial road closure and the road will be reduced to a single lane with a circular one way system round Garden Street. An Archaeologist has been appointed and a Consultant who will assist with exhumations has also been sourced. A meeting with the new Minister, Mandy Ralph, has been scheduled for week beginning 11th November 2019 to discuss issues regarding site access and also to identify upcoming church events that may require restrictions on work being carried out or, if necessary, a temporary cessation of work. It will be a six month construction however this could extend if weather or other problems cause delays in the work. An architect from Professional Design Services, Lynn Yule, a Conservation Architect with

previous experience of Church Projects, has been appointed to provide guidance and advice. A Discussion then followed.

Tarbolton Moss Landfill Site

Chairman advises that there are no further updates at present. Cllr Dettbarn stated that SEPA have expressed an interest in attending a Community Council meeting in the New Year. A Discussion followed.

Christmas Tree & Lights

Chairman advises that Christmas Lights have been received and a Christmas tree has been ordered.
