#### 7. Reports

A written report was received from Treasurer Ian Ferguson, stating that the Community Council had received a letter from Jeane Freeman MSP regarding Tarbolton Landfill. It stated that she was aware of the situation and would be kept updated with any developments and that she had also written to the Environment Secretary regarding the situation.

## 8. Special Reports

South Ayrshire Council report on removal of trees and repair of cemetery wall at Tarbolton church

Dino McKee of Clancy Consulting Limited advised that the wall was in very poor condition and would have to be repaired. The large trees in the cemetery grounds will have to be felled and removed.

A lengthy discussion followed, at the conclusion of which, it was confirmed that Lizzie Linton would be setting up an information session for the community at Tarbolton Community Campus in October. Fiona Ross advised that the felling of the trees was scheduled to take place in January 2019, with the need for part of Cunningham Street to be closed to traffic for approximately five days, and that the work to repair the wall would begin in spring 2019 and would take approximately 6 months to complete. Ayrshire Roads Alliance will be approached in order to request a one way system be put in place on Cunningham Street for the duration of the works.

A discussion followed regarding the temporary closure of the old Tarbolton Primary School grounds. Robbie Mann advised that the grounds had been closed in order for the developer of the site to do test drilling.

Joe Dalling advised that it had been brought to his attention that the old school building was to be demolished and 14 new properties were to be built on the site.
