### **Planning & Licencing Report**

No new applications have been submitted. Discussion took place about Daisybank, James Street, Tarbolton and progress being made which will hopefully ensure the property is brought back to a good condition and will last for many years to come.

Construction of new properties by Hayhill Development with some properties already finalised and new residents moved in.

### **Communications Report**

Audrey Gatt presented the results from the Place Planning survey which has been completed by a number of residents. She would like more surveys completed to ensure we have a broad range of opinions from residents. The results are highlighting a number of issues that can be used to develop our Place Plan.

Flyers have recently been issued to every household in the community so hopefully this will improve the quantity of surveys completed.

More information regarding the development of a Place Plan can be found on the Planning and Development website on South Ayrshire Council website. If we think there is a piece of land selected for housing that we feel shouldn't be then we can fight for that to be declassified in LDP 3.

# **Elected Members Report**

Councillors Ferry & Dettbarn are keen for more surveys to be completed and can assist with development of a Place Plan and this can be used to request funding through the Ward Grants that could be used to improve areas that require capital funding. One area discussed could be development of an allotment for the whole community.

### Gala Day 2024

Progress is going well in terms of the Gala Day on 1<sup>st</sup> June. There has been a positive response from small businesses requesting stalls. We are awaiting decision from South Ayrshire Council for our application for Destination South Ayrshire Grant. Following this being available we withdrew our application to the National Lottery Fund. Last meeting was cancelled by South Ayrshire Council as venue was not available. A discussion on progress with Gala Team will take place after Community Council meeting today.

# **Any Other Competent Business**

Community Facility - The availability is an issue due to the security system being linked with the school and therefore we are unable to use the facility without South Ayrshire Council arranging staff cover to activate the alarm at the end of any activities. Details to be passed to Stephen Ferry and he will take up with Lets. Is it possible to separate the alarms from community facility from school possibly using the Ward Capital funding.

Tutoring Sessions – Still going well and are continuing every week.

Stagecoach Buses - No improvements to bus service. Despite complaints there has been no response from Stagecoach. Consultation to be carried out. Councillors are trying to liaise with them.

Spring/summer planting – Meeting been arranged with Co-Ordinator from Grounds Maintenance to discuss taking our project forward.





Tarbolton Landfill – New Consultants have been appointed who will survey the site and will report on this.

- 4. The new Community Planting project commenced last year and a small team has been developed to build on its success.
