Participatory Budgeting funding application has been submitted and residents are now able to vote. We are one of the options for our area. Event is taking place on 9<sup>th</sup> September so we will know then whether we are successful. This is for installation of new notice boards.

## **Elected Members Report**

## **Light Up Tarbolton 2024**

Funding received from Lottery Scotland for new lighting. Event will take place on Saturday 30<sup>th</sup> November. Plan to have 2 trees – one at the Cross and one at the grassy area in the middle of the village. Matthew and Caroline to meet to discuss. Meeting to take place with Centre Great re installation of power for new tree. Extend the lights along Westport and see what we have left over.

## **Place Planning**

Conversations have taken place with Audrey Gatt. Council had requested our place plan to be developed and ready for October. They have now advised that we have until April 2025 to provide this.

## **Any other Competent Business**

Tarbolton Landfill. Report received from Albion Environmental who were appointed by Scottish Government. A variety of options have been discussed. Report now with Scottish Government to determine progress. Minimum option would cost circa £1 million. Japanese Knotweed is still an issue.

Ayrshire Roads Alliance have been in touch regarding the introduction of the 20 mph measures. 20mph measures are close to being approved. Robbie has asked for sight of the proposals. They will put forward their recommendations regarding better crossing facilities to South Ayrshire Council who will take this forward.

Caroline has submitted her resignation as Secretary to the Community Council. Robbie thanked her for her contribution and requested any volunteers for a new Secretary.

Cathy has submitted her resignation as Vice-Chair to the Community Council. Robbie thanked Cathy for her contribution and requested any volunteers as Vice-Chair.
